MEMORANDUM OF UNDERSTANDING (MoU) and cooperation between Alumni Associations of the Manager Training Program

The representatives of the Alumni of MTP hereinafter collectively referred to as" Parties "in order to develop mutually beneficial cooperation, reached an understanding on the following:

§ 1. Objectives

- (a) Exchange information, experiences and technologies in the field of promotion and provision of services;
- (b) Identification of business opportunities, as well as exchange of information on potential clients /projects in the sphere of products & services (hereinafter the "Projects");
- (c) Plans, programs, presentations, protocols, agreements and other documents by directions of cooperation defined by this Memorandum, as well as within relevant to the Parties to the projects;

§ 8. Final Provisions

- (a) Changes in this Memorandum may be amended at any time by an exchange of letters between the Parties with an agreement of at least 51% parties agreeing to the same.
- (b) All financial and other specific relationship arising from the conditions of this Memorandum shall be governed by the Parties through the conclusion of separate bilateral agreements.
